R&D Tax Credits (powered by ABGI)	Our team uses a unique combination of technology, tax and financial expertise to secure the highest possible government funding for organisations. Our consultants efficiently gather information and write the Technical Report needed for company tax returns. We also provide Enquiry Defence free-of-charge in case of queries from tax authorities.
Grant Funding	UK companies can tap into a huge range of grants and subsidies. We offer an end-to-end grants consultancy service, which includes writing and submitting grant applications, advising on the potential eligibility of projects and supporting you in the development of appropriately costed project plans.
Patent Box	The UK's Patent Box scheme enables companies that hold qualifying IP rights or an exclusive IP licence, and who receive relevant IP income, to benefit from a reduced rate (10%) of corporation tax on the relevant profits. We'll help you compile and assess these costs and profits, and prepare a report and associated calculation for inclusion in your tax return.

Research & Development Allowances (RDAs)	RDAs let you write off 100% of the cost of capital items used for R&D in their year of purchase, meaning your company gets the tax relief immediately. When preparing an R&D tax credit claim, we'll examine any project-related purchases and consider including these as capital items in your claim.
Enquiry Defence	HMRC are auditing more and more R&D Tax Relief claims every year. Our Enquiry Defence team can help businesses facing an HMRC enquiry – we'll review the claim and defend it where appropriate, advising on the best defence strategy and negotiating with the relevant tax authorities until an agreement is reached.
Video Games Tax Relief (VGTR)	The VGTR scheme comes with strict eligibility criteria, which have left many software developers wondering whether their games qualify. Companies can claim both VGTR and R&D Tax Credits. We'll navigate the complex eligibility criteria on your behalf to ensure you maximise returns from both tax incentive schemes.




